SCHOOL LEVY ELECTION

Tuesday, May 6, 2014 Polls Open Noon to 8 p.m. at Montana City School

Montana City School will conduct its annual levy election on Tuesday, May 6, 2014.

OPERATIONAL LEVY

The Montana City School Board of Trustees is asking voters to consider a general fund levy in the amount of \$30,150.00 to operate and maintain Montana City School.

The ballot will read:

Shall the district be authorized to impose an increase in local taxes to support the general fund in the amount of Thirty Thousand One Hundred Fifty and No/100 Dollars (\$30,150.00), which is approximately 4.8 mills for the purpose of operation and maintenance of Montana City School District No. 27?

Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$6.28 yearly and on a home with a market value of \$200,000 by approximately \$12.57 yearly. The durational limit of the levy is permanent once approved by the voters.

VOTING

Polls will be open in the mudroom, near the old gym, from noon to 8 p.m. Parking is available by the stone building for easiest access to the room.
